A registration form must be completed for all children attending Extended Day whether on a contract or on an occasional use basis. Subsequent changes to a contract schedule must be requested in writing using the appropriate form available from the Extended Day Director. **Contract accounts need to submit a \$200 non-refundable registration fee which will be credited to your account.**

Extended Day Occasional Use must complete a drop-in form, available at the office, indicating the day of the drop-in. You will be asked to sign this form when you are picking up your child and a monthly bill will follow in the mail.

Extended Day fees may be paid at the Business Office with cash, check or credit card (Visa, Mastercard or Discover). Contract accounts and occasional use not paid within 10 days become past due and are subject to a \$10 monthly finance charge. A service fee of \$35 will be charged to your account for any check returned by the bank for non-payment. Note that late payments or failure to pay finance charges may result in exclusion from Extended Day until accounts are made current.
